The purpose of this grant is to support faculty member's innovation and engagement in a deliberate, documented process of reflection, planning, action, and observation intended to improve teaching and student success.

The second year grant extension includes **\$3000 for the continued implementation of the move of The Martin W. Essex School for the Gifted and Talented™ to Ashland University for summer 2021, as outlined in your 20-21 report.**

You will receive the original grant contract from the Provost's office, where you will notice additional signature lines at the end of the contract for year two. Please sign that contract, have your department chair and dean sign it, and then forward it to the Provost's office. You will also get information to select the funding payment options.

As a reminder, in addition to the final report, you agree to share outcomes in writing and/or through oral presentations to the campus community and/or community-at-large in the year following the grant period. CITE will coordinate this with you after your grant is complete. You also agree to remain at Ashland University for at least one year following the receipt of the award.
