#### Name of High Impact Teaching and Learning Grant Application:

Moving Essex from Otterbein to Ashland for June 20-25, 2021 School

#### **History of Essex and Governor's Summer Institute**

The move of the Martin W. Essex School for the Gifted and Talented ™ from Otterbein University to Ashland University for the 2021 June 20-25 46th class is well under way. The school started as a weeklong residential experience for intellectually gifted high school seniors in 1976 at The Ohio State University. After Essex was in operation, a need for gifted high school sophomores and juniors was addressed through the Governor's Summer Institute which started in 1989. In 2009 when the Ohio legislature pulled the full funding of Essex and also the Governor's Summer Institute from their budget, an RFP was issued for Essex and Otterbein University became the new home starting with the class of 2011. The Governor's Summer Institute disappeared.

Due to the lack of support from the state for Essex, the coordinators of this school had to charge tuition and write for grant support with the intent of turning no student away due to inability to pay. Other changes in the move were offering the experience to any high school junior or senior who had a gifted identification in one or more areas as in the Ohio Gifted Operating Standards. The 2020 school was the last one at Otterbein and for the first time was held virtually.

#### Reason for Application to CITE for High Impact Teaching and Learning Grant

Co-directors Farrekopf and Groman wrote for the CITE High Impact grant to get the Essex move started. The Essex trademark was transferred from Otterbein to Ashland. The grade levels for the school were expanded to include high school sophomores as well as juniors and seniors who are gifted in one or more areas as identified by the state of Ohio. The decision was made to combine the best of the Essex School and the Ashland Governor's Summer Institute which had lost funding from the state in 2009 as well. The themes of Transitioning and

Transforming and a focus for student learning on Leadership and Change were set as the guiding principles.

#### **Action Plan**

Invitations to serve on the Essex at Ashland Steering Committee were extended and this group has been meeting once per month since September 2020. Through their efforts guided by Farrenkopf and Groman, a budget was formed and the cost of the school was set at \$150 with financial aid opportunities for those who needed assistance. The 2021 student application was updated and shared with educators across the state of Ohio. Educational Service Center and district contacts were identified and emailed to share an announcement that Essex had moved to Ashland. Undergraduate Admissions Representative Henry Stafford was contacted to share the news when working with Ohio high schools. He is also the liaison for the Office of Diversity and Inclusion and knows of our desire to promote this school to underrepresented gifted populations.

We had a virtual booth at the fall 2020 Ohio Association for Gifted Children conference and shared information as well as offered a raffle certificate for a free registration. The Center for Talent Development at Northwestern University was contacted to become part of their 2021 Summer Opportunities booklet; we also purchased addresses of those sophomores, juniors, and seniors who had been identified as part of their Talent Search. Google forms for registration and also for instructors to submit a proposal to present were developed and distributed.

A decision was made early on to keep the school virtual for one more year. We selected the platform VirBELA because of its track record with use by our Founders School for their annual PD meeting and also for the Ashland Leadership Academy Seminar series in January, February, and March of 2021. A Deep Learning grant application from the Martha Holden Jennings Foundation was completed and news of the award came to us in March. This grant was to be for the technology aspect of the Essex school but we were not awarded all that we needed to cover costs of VirBELA providing our training. Because Founders has a year-long subscription with VirBELA, we will be able to use their membership and expertise to provide the necessary training and support for the students and instructors at Essex 2021. This is a great example of the partnership we are forging between COE and Founders.

The registration deadline for 2021 Essex students is May 31, 2021. We are in process of following up with ESCs and school districts. Our keynote speaker Andrew Mahoney is the

scholar who created the Gifted Identity Formation Model. Other instructors have been contacted and are submitting proposals for plenary and intensive sessions.

Currently awarded grant funds have been used for transfer of the "Martin W. Essex School for the Gifted and Talented" name to Ashland University [\$40], the Ohio Association for Gifted Children toward a virtual booth at the Fall, 2020, conference [\$250], advertising in Northwestern University's Summer Opportunities booklet and purchase of Talent Search names [\$462.55], and postcard advertisements [\$245.69]. The remaining funds from the grant are allocated for two of our Essex at Ashland 2021 intensive instructors.

We have attached documents reflecting our progress to date and extend our sincere appreciation for the opportunity to receive support from the Center for Innovation and Teaching Excellence.

#### Year Two of High Impact Teaching and Learning Grant

We are looking forward to offering Essex as an in person residential experience in June of 2022. We request a second year of funding through the CITE High Impact Grant opportunity. Due to the fact that the fiscal year spending deadline is in May, the second year of funding will be spent for the other Essex at Ashland 2021 intensive instructors.



- 1. Assignment. Assignor hereby irrevocably transfers and assigns to Assignee, and Assignee hereby accepts and assumes from Assignor, all of Assignor's right, title and interest in and to (i) the Trademark, (ii) any trademark, service mark, trade name, domain name or other source identifier that is a derivative of or confusingly similar to the Trademark, (iii) any registration or application for registration of any of the foregoing (including Federal Registration No. 4005095), and (iv) any goodwill associated with any of the foregoing.
- 2. <u>Representations and Warranties.</u> Assignor represents and warrants to Assignee:
  - (a) Assignor has the right, power and authority to enter into this Agreement;
  - (b) Assignor is the exclusive owner of all right, title and interest, including all intellectual property rights, in the Trademark;
  - (c) The Trademark is free of any liens, security interests,

encumbrances or licenses;

- (d) The Trademark does not infringe the rights of any person or entity;
- (e) There are no claims, pending or threatened, with respect to Assignor's rights in the Trademark;
- (f) This Agreement is valid, binding and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and
- (g) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.
- 3. Entire Agreement. This Agreement, contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof.

Career development is just that, a developmental process and should be approached as such. This presentation will be a discussion/presentation format covering the career development process for the gifted student and creating an awareness of your potential.
