Combined Concurrent: A shared one-hour session with each presentation allotted 30 minutes. Audio-visual equipment is supplied in meeting rooms (LCD projector, screen, podium, panel table, microphones, and speakers). Presenters must supply their own computers.

Poster: A visual representation of the topic displayed on a poster board (4 feet tall by 4 feet wide). Presentations should be about 15 minutes long followed by discussion. Depending on the flow of the audience, the presenter(s) may need to repeat the presentation. Posters must be displayed by Friday morning and remain on the boards until Saturday afternoon. There is no audio-visual equipment or electricity.

Both submitters and co-presenters have been notified of this acceptance.

Please notify us whether you will accept or decline this invitation to present by signing the speaker agreement by May 4, 2020. It is the first task upon login.
